## **Impacts to Governmental Entities**

Many governmental units are ARES-served customers ranging from cities and municipalities, county governments, school districts, park districts, Illinois state government buildings and offices, among others. Electricity rates for ARES-served governmental units throughout Illinois will increase substantially because of above market power costs from Tenaska's Taylorville Energy Center. These rate increases will occur annually over 30 years of mandated power purchases.

Non-residential electric customers with a peak demand of up to 100kw in the ComEd service territory have been declared a competitive service and are largely served by ARES. Non-residential electric customers with a peak demand of 400kw and up in the Ameren service territory have been declared a competitive service and are largely served by ARES (220 ILCS 5/16-113). Note: Residential and small commercial customers can not be declared a competitive service until July 1, 2012.

The bottom line is that almost all power used by major metro area governmental units is ARES provided. Many small, medium and large governmental units located in suburban and downstate Illinois are ARES-served customers.
